#### What is the Delegate Assembly:

The annual Delegate Assembly is the meeting where school board members vote on the proposals submitted by local school boards through the resolutions process.

If the proposals are adopted, they become Position Statements for the association, which guides the work for association staff.



#### **How to CHOOSE a Delegate:**

Each IASB school board is entitled to one voting delegate at the Delegate Assembly.

Each school board determines their own process for selecting their delegate.

(Only roster managers can register delegates.)





### How to REGISTER a Delegate:

Your district roster managers must <u>register the school district's delegate</u> online. One person per district may be registered as the delegate. Once registered, the delegate will need to pick up the packet and credentials at the Joint Annual Conference.

Although pre-registration is recommended, onsite in-person registration will be available. Onsite registration and packet and credential pickups will take place all day Friday in the IASB Info Center, and Saturday morning prior to the Delegate Assembly at the Hyatt Regency West Tower location.



### How to PREPARE for Delegate Assembly:



Review the 2023 Resolutions Committee Report with your full School Board.

Decide as a board how you want your registered delegate to vote at Delegate Assembly.




#### Office of the Vice President (1 year term): Tracie Sayre
