The Board of Education of West Prairie CUSD 103, Colchester, Illinois is seeking qualified applicants for the position of Superintendent. The Board wishes to select a superintendent who will begin work on July 1, 2025.

A multi-year employment contract is expected to be negotiated with the final candidate. Salary and benefits will be based on experience and expertise with a salary range expected to be \$120,000-\$140,000 and benefits expected to include health insurance, life insurance, sick days, personal days, vacation days, bereavement days, professional dues, TRS pension, and travel expense reimbursement.

GENERAL INFORMATION ON THE DISTRICT AND THE AREA

LOCATION — West Prairie is primarily located in the western part of McDonough County in West Central Illinois and extends into Hancock and Henderson counties. The district is comprised of several communities, including Blandinsville, Colchester, Good Hope, Sciota and Tennessee, covering 240 square miles.

TYPE — PreK-12: 575 Students.

STAFF — 3 Principals, 1 Assistant Principal, 62 Teachers, 59 Support Personnel.

CURRICULUM — The West Prairie Community Unit School District is a 1:1 initiative district using iPads and Chromebooks for students K-12. STEM curriculum is offered at all levels. West Prairie is known for its award-winning Agriculture and FFA programs. MTSS, a multi-tiered system of support

is used to address academic, social, emotional and behavioral deficits. Music and art are provided at all levels. The ARC Core Curriculum is used to teach the ELA standards in K-6. The Engage NY Curriculum is used to teach the math standards in K-6. STEMscopes is used to teach science and STEM curriculum in K-6. Social Studies Alive! Is used to teach social studies curriculum in grades 4-6.

SPECIAL PROGRAMS — Title I services are school-wide for both the North and South Elementary. Preschool for All programming provides four classrooms for 3 and 4-year-olds. The high school offers a variety of dual credit classes in conjunction with Carl Sandburg College, and participates in the McDonough County CEO program.

SPECIAL SERVICES — The district makes use of the wide variety of programs and services offered by the special education cooperative. Local programs are established in each school.

FACILITIES — West Prairie Jr/Sr High School (7-12); West Prairie North Elementary (PreK- 6); West Prairie South Elementary (PreK-6).

TRANSPORTATION — The district owns and operates its own buses and other vehicles.

FOOD SERVICES — The district operates its food service program under the Community Eligibility Provision. All students are eligible to receive a free breakfast and lunch provided by the in-house food service department. Meals are served at all three schools.

MEMBER OF — Illinois Association of School Boards, West Central Illinois Special Education Cooperative, Western Area Career Systems (vocational education cooperative), Western Area Schools Health Benefit Plan, Western Illinois Purchasing Cooperative, The Prairieland Conference (high school), Sand Valley Conference (junior high school).

MEDICAL — The region is served by Mc-Donough District Hospital, Memorial Hospital in Carthage with a medical clinic in Colchester, and Blessing Medical Center in Quincy. CULTURAL — Residents of McDonough County have access to a wide variety of community and cultural experiences. Western Illinois University offers nearly year-round programs in music, drama, and the arts. Amtrak services to Quincy, Galesburg and Chicago.

RECREATION — Argyle Lake State Park is located within the school district with Spring Lake close by. Both parks offer ready access to boating, hiking, fishing and camping. A number of golf courses, parks, and ballfields are within the district or nearby.

PLACES OF WORSHIP — There are many faith-based organizations within the school district and nearby. Local congregations are very supportive of the work of our schools.

RETAIL — McDonough County has a large base of retail stores including local merchants or service businesses, regionally-based markets, and national chains.

FRATERNAL AND PROFESSIONAL

ORGANIZATIONS — There are several professional organizations within the district, including International Lions Club and the Colchester Area Business Association. Fraternal and Civic organizations in the surrounding area include the Masonic Lodge, the Fraternal Order of Eagles, United Way and others.

COLLEGES — Western Illinois University is adjacent to the school district and offers access to a wide variety of graduate and undergraduate programs. The school district lies within the boundaries of Carl Sandburg College [associate degree or certificate programs], and Spoon River College also has a nearby facility.

INDUSTRY — Yetter Manufacturing, Cardinal Point Wind Farm, and McDonough Solar I, LLC CSG are located within the school district. Nearby large industrial employers include NTN Bower and Pella Windows. The region is home to a variety of small industries, many of which center on agribusiness.
