GENERAL INFORMATION ON THE DISTRICT AND THE AREA

LOCATION – Spring Valley C.C. Elementary School District 99, 16.921 square miles in size is located on the Illinois River on Route 89 five miles south of Interstate 80 and three miles west of Peru, Illinois. The district is midway between Chicago and the Quad Cities and midway between Rockford and Bloomington or Peoria. The school district encompasses the communities of Spring Valley (population 5,461), Seatonville (317), Hollowayville (40) and the surrounding rural area.

Students' needs are also met by reading improvement teachers, interventionists, a full EL program, after school programs for students at risk of failing and two guidance counselors. Other student services *are* provided through the BMP Tri-County Special Education Cooperative.

School improvement plans, curricular alignment and professional development activities are being implemented to insure continued progress meeting the Illinois Learning Standards. With over 700 Apple devices, technology has played a key role in the district's educational plan. Fifth grade is organized in a block schedule to ease the transition from self-contained fourth grade to the junior high block schedule. Students are offered a full range of extracurricular activities which complement their school experiences.
